## Rules

- Avoid overexposure.
- Wear protective eyewear.
- Always contact your physician when taking any type of medication prior to tanning. Always advise salon of any medication changes. A list of photosensitizing medications is available upon request from the salon operator.
- Never tan twice in a 24-hour period, either indoors or outdoors.
- No one under the age of 14 is allowed to use the tanning facility. Anyone between 14 and 17 years of age must have a parent or a legal guardian sign the consent form in the presence of the salon operator.
- Lotions not approved by Tropical Tan management may cause damage to the acrylics. If in doubt, consult the salon operator.
- Remove all jewelry and other abrasives from clothing to avoid damage to the acrylics.
